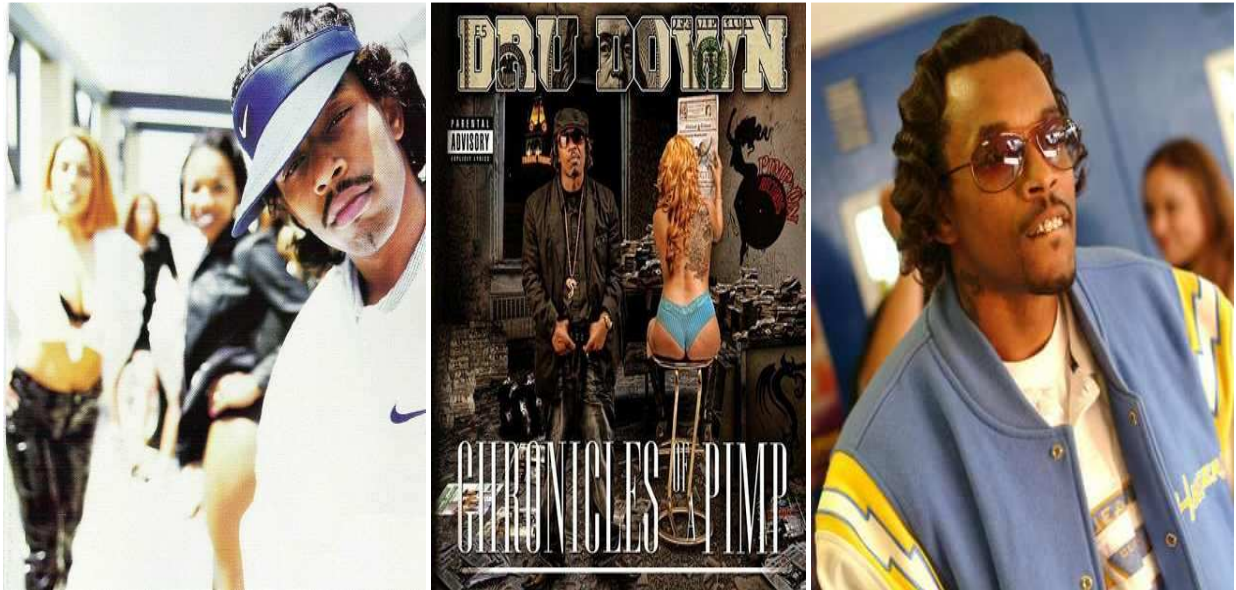


DRU DOWN



Darnel Robinson, better known by his stage name **Dru Down**, is an American rapper and actor from Oakland, California.^[1] He is a member of The Regime, a collective of rappers that includes Yukmouth, Tech N9ne, Messy Marv, BG Bulletwound, Dorasel, Grant Rice, Tha Realest and Gonzoe... Dru Down debuted in 1994 with Explicit Game, scoring a hit with the single "Mack of the Year"; the record also served as a launching pad for his Bay Area cronies the Luniz. Down returned in 1996 with Can You Feel Me; that same year, he also made his film debut in Original Gangstas. 2001's Pimpin' Phernelia, 2002's Gangsta Pimpin', and 2006's Cash Me Out (with Lee Majors) followed

Oakland rapper Dru Down debuted in 1994 with Explicit Game, scoring a hit with the single "Mack of the Year"; the record also served as a launching pad for his Bay Area cronies the Luniz. Down returned in 1996 with Can You Feel Me; that same year, he also made his film debut in Original Gangstas. 2001's Pimpin' Phernelia, 2002's Gangsta Pimpin', and 2006's Cash Me Out (with Lee Majors) followed the title track of his 1996 album *Can You Feel Me* was a minor hit. He's performed with Spice 1, E-40, Richie Rich, Shock G, Yukmouth, The Luniz, and other Bay Area rappers, and introduces the 2Pac song "All About You". Dru Down also plays a part in the 1996 movie *Original Gangstas* and in 2001 he released a movie of his own named *Hip Hop & Porn Stars*. Currently, Dru Down released *Chronicles of a Pimp* on November 16 2010.

ARTIST ENGAGEMENT AGREEMENT

This Artist Engagement Agreement for the performance of the Artist, **Dru Down** p/k/a **Darnel Robinson** described below made June ____, 2011 between the undersigned “**Purchaser**” and the “**Artist**” to appear and the undersigned “**Artist**” and “**Purchaser**” to fulfill respective obligations as described below, as independent contractors.

The Purchaser hereby engages the Artist and Artist hereby agrees to appear and perform at the respective “**Event**” hereinafter provided with all of the terms and conditions herein set forth including those entitled “**Additional Terms and Conditions:**”

1. NAME OF ARTIST: Dru Down

2. VENUE OF ENGAGEMENT:

4. CITY OF ENGAGEMENT: Las Vegas, NV

6. DATE OF ENGAGEMENT: 06/___/11

6. PRICE AGREED UPON \$2,000.00

All payments shall be paid by bank wire, certified check, or cash by the Purchaser to Artist Management.

6. **RIDER:** Purchaser shall supply to Artist all requirements as established in the subsequent attached rider: PLEASE SEE RIDER.

7. **FEE:** In consideration of the rights granted to Purchaser hereunder, Purchaser hereby agrees to pay the sum of (\$1,500"). Of the Fee shall be payable by bank wire transfer upon the execution of this agreement. The remaining (*\$500.00*) of the **Fee shall be payable by cash by 4:00 p.m. on the day of aforementioned "Event."**

8. **CONTROL:** The Purchaser shall at all times have complete control, supervision, and direction over the venue where Artist is asked to appear and accepts complete liability for any activity and subsequent consequences. The Purchaser expressly reserves the right to control the manner, means and details of the Event as well as the ends by which to be accomplished. The Purchaser, or their agent, shall enforce disciplinary measures for just cause, and carry out instructions as to the selection of the venue and manner of operation. In the event that Purchaser refuses or neglects to perform any of its obligations herein stated, and/or fail to make payment as provided herein, Purchaser shall have the right to refuse to cause Artist to appear at the Event and shall retain any amounts therefore paid.

9. **ARTIST OBLIGATIONS:** The Artist shall appear at the Event, as requested, and remain for no less than one (1) hour. The expiration of the hour shall commence upon the arrival of said Artist at the venue, independent of the Purchaser's failure to adhere to the manifested requirements found in the aforementioned Rider. Security shall arrive at the venue with Artist to evaluate required compliance with stipulations provided in the aforementioned Rider. The Artist, manager, or representative agrees and guarantees to appear for acknowledgement only and will be under no circumstances obligated to remain in excess of one hour,

10. **TAXES:** The Purchaser agrees to prepare and file all tax information required of a person who hires an independent contractor and Artist, and its representatives, and does not agree that they have sole responsibility for the payment of any federal or state taxes arising from the monies paid by Purchaser to Artist for appearing.

11. **ADVERTISING:** Purchaser shall be entitled to advertise and promote the presence of Artist at the above mentioned date. Artist acknowledges that Purchaser will rely on the

terms hereof in all such promotions and advertising and in flyers to be printed setting forth the name, dates and time of aforementioned appearance. Artist hereby acknowledge and agree that Purchaser may use his name, photograph, video and likeness in all such promotions, advertising or other activities used to augment productivity with PRIOR WRITTEN APPROVAL.

12. **INSURANCE:** Purchaser shall, at its sole cost and expense, carry and maintain a comprehensive liability insurance policy against any claim. Such general liability policy shall have the limit of \$1,000,000 for any one (1) accident, occurrence or claim, including bodily injury, personal injury or property damage.

13. **AUTHORITY TO EXECUTE:** The Event Coordinator and/or manager who is executing this Agreement on behalf of Artist hereby warrants and represents that he has the full power and authority to bind Artist on whose behalf he is executing this Agreement and acknowledges that he is making this representation and warranty with the understanding that Purchaser is relying thereon.

14. **INDEMNITY:** Purchaser hereby indemnifies Artist and Artist's representatives, and holds each of them harmless from any claim, liability, cost or expense (including, without limitation, reasonable attorneys' fees) arising out of any claim, demand or action by a third party which arises from Purchaser's production and promotion of the "Event," except to the extent such claim arises from the negligent actions of Artist.

15. **THE AGREEMENT:** The Agreement of the Artist to appear is subject to proven detention by sickness, accidents, riots, strikes, epidemics, acts of God, or any other legitimate conditions beyond their control. If artist is unable to appear by any reason beyond Artist control or at the detriment of Purchaser, the amount submitted to secure the appearance of Artist shall be non-refundable.

16. **MEMBERS OF UNIONS OR GUILDS:** Members of unions or guilds, which may include Purchaser or members of this unit, agree to accept sole responsibility for complying with the rules and regulations of said unions or guilds of which they may be members.

17. **CONTRACT:** This contract constitutes the sole, complete, and binding agreement between the Purchaser and Artist. Artist, his employees and representatives assume NO responsibility or liability as between the Purchaser, Artist or respective venue. Nothing herein contained shall create any association, partnership or joint venture between the parties; it is understood that each party is performing its obligations as an independent contractor.
18. This agreement has been entered into in the State of Nevada, and its validity, construction, interpretation and legal effect shall be governed by the laws of the State of Nevada applicable to agreements entered into and performed entirely within the State of Nevada. The Federal and State courts located in Las Vegas, NV shall have the exclusive jurisdiction over any and all disputes arising from or related to this agreement. Should any portion of this Agreement be found to be invalid or unenforceable in any jurisdiction, it shall not affect the remainder of the Agreement.
19. This Agreement is intended to be fully binding on all the parties hereunder provided this Agreement shall not become effective until formally approved by signature of Artist representation which must occur within two (2) business days from the date hereto and executed by all parties listed. It is contemplated that this Agreement between the parties containing additional terms and conditions customarily contained in agreements of this type (e.g. rights to secure life insurance, indemnities, conduct clauses, protection of trademark, reasonable notice and cure provisions, where appropriate, etc.), all of which shall be negotiated in good faith. Provided, however, that until such more detailed agreement is executed, this Agreement shall remain in full force and effect after the approval of the Artist.
